ICM Crescendo Music Royalty Fund seeks to provide investors with an attractive, durable and uncorrelated yield by directly investing in music intellectual property.

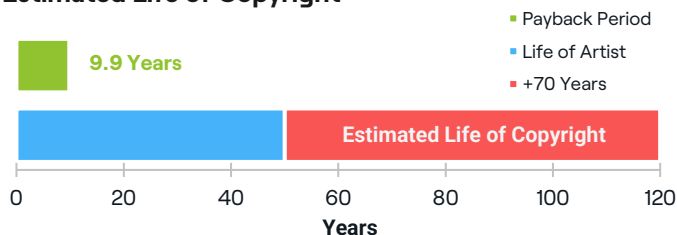

Payback Period vs. Estimated Life of Copyright

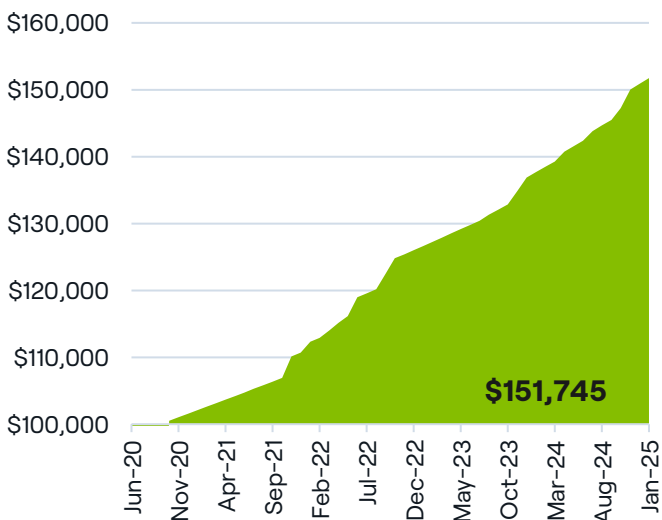

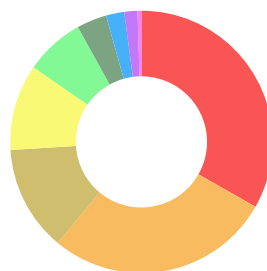

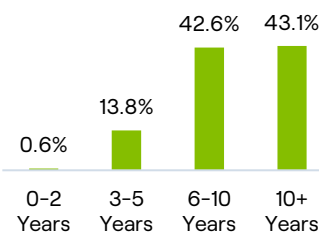
